ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Final Offer Price and Net Proceeds from the Global Offering

- The final Offer Price has been determined at HK\$2.0 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the final Offer Price of HK\$2.0 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deducting the underwriting fees and commissions and other estimated expenses payable by the Group in connection with the Global Offering, are estimated to be approximately HK\$140.0 million. The Company intends to apply such net proceeds from the Global Offering in accordance with the purposes as set out in the section headed “Net Proceeds from the Global Offering” in this announcement.

Applications and Indications of Interest Received

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been moderately over-subscribed. A total of 14,309 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and by **electronic application instructions** given to HKSCC via CCASS and through the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service for a total of 176,604,000 Hong Kong Offer Shares, representing approximately 17.7 times of the total number of 10,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the over-subscription in the Hong Kong Public Offering is more than 15 times but less than 50 times of the number of Offer Shares initially available under the Hong Kong Public Offering and the International Placing was slightly over-subscribed at approximately 1.14 times, the reallocation procedure as described in the paragraph headed “The Structure of the Global Offering – The Hong Kong Public Offering – Reallocation” in the Prospectus has been applied. 20,000,000 Offer Shares have been reallocated from the International Placing to the Hong Kong Public Offering. As a result of such reallocation, the final number of the Offer Shares allocated to the Hong Kong Public Offering is 30,000,000 Offer Shares, representing 30.0% of the total number of the Offer Shares initially available under the Global Offering.

The International Placing and Over-allotment Option

- The Offer Shares initially offered under the International Placing have been slightly over-subscribed for a total of 102,484,000 International Placing Shares, representing approximately 1.14 times of the total number of 90,000,000 International Placing Shares initially available under the International Placing. Following the reallocation as described above, the final number of Offer Shares allocated to 166 placees under the International Placing comprises 70,000,000 Offer Shares, representing 70% of the total number of Offer Shares initially available under the Global Offering. A total number of 72 placees have been allotted five board lots of Shares or less, representing approximately 43.37% of total number of placees under the International Placing. These placees have been allotted approximately 0.34% of the Offer Shares under the International Placing after reallocation. A total number of 63 placees have been allotted three board lots of Shares or less, representing approximately 37.95% of total number of placees under the International Placing. These placees have been allotted approximately 0.21% of the Offer Shares under the International Placing after reallocation. A total number of 61 placees have been allotted two board lots of Shares or less, representing approximately 36.75% of total number of placees under the International Placing. These placees have been allotted approximately 0.19% of the Offer Shares under the International Placing after reallocation. A total number of 54 placees have been allotted one board lot of Shares, representing approximately 32.53% of total number of placees under the International Placing. These placees have been allotted approximately 0.15% of the Offer Shares under the International Placing after reallocation.
- To the best knowledge of the Directors, none of the Sole Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers, the Underwriters and their respective affiliated companies and connected clients of the lead broker or of any distributors (as defined in Appendix 6 to the Listing Rules) has taken up any Offer Shares whether in its own names or through nominees for its own benefit under the International Placing. To the best knowledge of the Directors, no Offer Share under the International Placing has been allocated to applicants who are (i) the Directors or existing Shareholders; (ii) core connected persons (as defined in the Listing Rules) of the Company; or (iii) close associates (as defined in the Listing Rules) of (i) and/or (ii), whether in their own names or through nominees. To the best knowledge of the Directors, the International Placing has been conducted in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules (the “**Placing Guidelines**”) and no Offer Shares placed by or through the Joint Global Coordinators and the Underwriters under the Global Offering have been placed with any core connected person (as defined in the Listing Rules) of the Company, connected client (as set out in paragraph 5(1) of the Placing Guidelines) (save as disclosed in the foregoing), or persons set out in paragraph 5 of the Placing Guidelines, whether in their own names or through nominees. No placees will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering and as such, none of the placees under the International Placing will become a substantial shareholder (as defined in the Listing Rules) of the Company immediately after the Global Offering.

- The number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08(1)(a) of the Listing Rules. The Directors further confirm that the three largest public Shareholders do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules and there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules. The Directors confirm that none of the Offer Shares subscribed by the placees or the public has been financed directly or indirectly by any of the Directors, chief executive, Controlling Shareholders, substantial Shareholders or existing Shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees and the public who has subscribed for the Offer Shares is accustomed to taking instructions from any of the Directors, chief executive, Controlling Shareholders, substantial Shareholders or existing Shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it.
- The Joint Global Coordinators confirm that there is no over-allocation in the International Placing, therefore, the Stock Borrowing Agreement will not be entered into and the Over-allotment Option will not be exercised. In view of the fact that there has been no over-allocation in the International Placing, no stabilising action will be taken during the stabilisation period.

Cornerstone Investor

- Based on the final Offer Price of HK\$2.0 per Offer Share and pursuant to the cornerstone investment agreement with the Cornerstone Investor as disclosed in the section headed “Cornerstone Investor” in the Prospectus, the number of Offer Shares subscribed for by the Cornerstone Investor has now been determined. The Cornerstone Investor, Kingkey Financial International (Holdings) Limited, has subscribed for 5,000,000 Offer Shares, representing approximately 5.0% of the total number of Offer Shares initially available under the Global Offering and approximately 1.25% of the total number of issued Shares immediately following the completion of the Global Offering. The Offer Shares to be subscribed for by the Cornerstone Investor will rank *pari passu* in all respects with the other fully paid Shares in issue and the shareholding of the Cornerstone Investor will be counted towards the public float of the Company.

- To the best knowledge of the Directors, save for the investment in the Company through the Cornerstone Placing, the Cornerstone Investor is an Independent Third Party, is not the Company's connected person (as defined in the Listing Rules) and does not have any other relationship, whether present or past, with the Group, the substantial Shareholders, Directors and senior management, any connected persons (as defined in the Listing Rules) of the Company or any of their respective associates save as disclosed in the paragraph headed "Cornerstone Investor – The Cornerstone Investor" in the Prospectus. The subscription of Offer Shares by the Cornerstone Investor under the Cornerstone Placing is not financed directly or indirectly by the Company, any of the Directors, the chief executive, any of the existing Shareholders or their respective close associates. The Cornerstone Investor is making independent investment decisions and the Cornerstone Investor is not accustomed to take instructions from a core connected person (as defined in the Listing Rules) of the Company, any of the Directors, the chief executive, any of the existing Shareholders, or their respective close associates in relation to the acquisition, disposal, voting or other disposition of the Offer Shares.
- Immediately following the completion of the Global Offering, the Cornerstone Investor will not have any board representation in the Company, nor will it become a substantial Shareholder of the Company. The Cornerstone Investor does not have any preferential rights in the Cornerstone Investment Agreement compared with other public Shareholders.
